### FROM OUR BOARD CHAIR

So, it is fitting that in 2020, as the COVID-19 pandemic dominated American life, Anixter Center saw fit to focus on its future goals through the development a multi-year strategic plan. Despite the pandemic's insistence that our concentration be centered on the present moment and its attendant challenges, Anixter Center still looked to define its future. And its future looks bright.

The agency could not have focused on its future if it was presently unwell. So much credit for the health of the agency today goes to Rebecca and the resilient, dedicated, and talented staff at Anixter, who continued safely providing many of the high-quality programs and services that our clients expect from us during the greatest public health crisis in a century. Moreover, an agency-wide focus on measurable goals and quality standards has led to strong and sustained audit results and increased pride in our program delivery. Our board is energized as well, with several new members joining in the past year, each with a unique perspective and skill set. Our growing and changing board has inspired discussions about exciting new directions and possibilities for the organization that only a few years ago might have felt out of reach.

2020 left us on the doorstep of a strategic plan that will strengthen the agency by focusing our efforts on a defined set of ambitious yet achievable goals. We have so many reasons to be proud of this year's accomplishments, and to be equally optimistic about the organization's future. I hope you'll stay close and partner with us in our successes.




#### SUMMARY OF AUDITED FY20 FINANCIALS

Total expenses \$17,564,568


Total revenue \$16,230,336
